Subject: Review of the Aircraft Noise Community Consultative Group Terms of Reference

1.0 Purpose

The purpose of this memo is to:

- present the draft version of the Aircraft Noise Community Consultative Group (ANCCG)
 Terms of Reference (ToR) incorporating the tracked recommended changes for members to consider.
- outline the process for members to provide feedback on the changes
- provide a timeline of key dates.

2.0 Background

Auckland International Airport Limited (AIAL) and Auckland Council (Council) advised members in a memo presented at the June 2024 ANCCG meeting that the ToR for the ANCCG would be reviewed. The review process began on 10th June 2024 and will conclude with submission of the finalised ToR to Council in April 2025.

The key actions completed to date include:

- During June and July AIAL collated a draft ToR which included all the suggested amendments received from members, local board reps, Catherine Harland and AIAL.
- At the end of August, the Council provided their feedback on the collated draft ToR. In response, AIAL convened in September to review and address the Council's comments.
 As part of this process, AIAL also sought legal guidance from Russell McVeagh to better understand its consultation obligations and ensure compliance.
- Later in September, AIAL and the Council reconvened to discuss the updates made to the
 draft ToR. This meeting resulted in a series of follow-up actions for AIAL to complete. By
 November, AIAL finalised these actions, incorporating the rationale for changes proposed
 by AIAL, the Council, and the outgoing Chair. The finalised draft ToR was then submitted
 to the Council for final review and feedback.





• In November final review and feedback was received from Council and AIAL incorporated these and finalised a draft version of the ToR.

3.0 Process for members to provide feedback

Members to review the draft ToR (separate attachment), consider the changes made and provide feedback at the December 2024 ANCCG or to ANCCG Secretariat@aucklandairport.co.nz by **31**st **January 2025.**
