4. Community Board Feedback

Puketāpapa Local Board- Julie advised that she had one constituent that was emailing her every day with regards to aircraft noise and at the last business meeting she attended on the 2nd February many members of the public expressed concerns. They also raised concerns about how complaints are handled and that more information is needed to be provided to them.

Maungakiekie-Tāmaki- Simon advised that he receives regular complaints from some of his constituents. Some of them a quite distressed when they call him and this has become more apparent with the publicity given to aircraft noise. He noted that he has had good support from Auckland Airport with understanding the process.

Mangere- Tasi advised that for his local board area things have gotten worse since the last meeting. He is getting a lot of feedback with regards to Great Barrier Airlines and Fly My Sky aircraft that regularly over fly the Mangere Bridge area.

Howick - David advised that there is been more awareness with regards to aircraft noise because of the 'SMART' trial. He has been approached by the local paper and would like assistance gaining the information required to help respond to them.

Auckland Council- Andrew noted some noise complaints are coming directly to the Auckland Council and are being passed through to Auckland Airport. Councilor Alf advised that at the Mangere Bridge residents rate payers meeting the aircraft noise issue was raised and the general perception from members of the public was that the 'SMART' approaches were still going on.
