# What we do

# The Trust's work

Auckland Airport set up the Auckland Airport Community Trust in 2003, following a decision by the Environment Court to approve a second runway. The Court decision required the airport to grant the Trust \$250,000 (adjusted by the Consumer Price Index) each year. The Trust distributes this money to the community around the airport to mitigate the impacts of aircraft noise and generate positive social benefits.

# Noise mitigation grants

Aircraft noise is an issue for airports around the world. Auckland Airport mitigates the impacts of aircraft noise in its neighbourhood in several ways, including by helping affected people install noise mitigation packages in their homes. The airport pays 100% of installation costs in the High Aircraft Noise Area (HANA) and 75% in the Moderate Aircraft Noise Area (MANA). People in the MANA who are in financial hardship can apply to the Trust for funding to cover the remaining 25% of the cost.

# Community grants

In past years the noise mitigation grants have made up a small share of the total funds available for distribution. Based on the Trust Deed, trustees have distributed surplus funds to the community in the Trust's 'area of benefit' as community grants. In past years the focus has been to support learning, literacy and life skills. In 2019 the trustees have widened this focus to benefit a greater range of people and activities.

# Responsive grants

In 2019 the Trust introduced a new micro-grant funding scheme. This grantmaking programme is designed to be responsive. Enabling a flexible approach to the changing conditions and needs of the community. The aim is to get small grants, to a maximum of \$2,500 to organisations quickly and easily to meet their immediate and small-scale needs.



# Chair's report

It is with great pleasure that I present this Annual Report for the year ended 30 June 2020 on behalf of the Auckland Airport Community Trust.

During the 2020 financial year we approved 12 noise mitigation grants valued at \$33,335 to assist qualifying residents suffering financial hardship install noise mitigation packages in their homes. The Trust also approved community grants during the annual round totaling \$243,021 to 18 organisations and continued its responsive microfunding grant programme for small grants not exceeding \$2,500.



During the 2020 year, we approved 11 microfunding grants totaling \$21,993 for a range of projects and organisations. We are starting to see examples of these rapid response grants creating opportunities for pilot programmes to transition to a wider audience.

For the most recent round of annual grants we received applications from 32 Organisations seeking a total of \$828,410. The Trust approved community grants totaling \$303,163 to 24 organisations, with a further 2 organisations funded to the value of \$4,937 from our responsive microfunding grant budget. The commitment of your trustees in carefully evaluating all applications cannot be emphasised greatly enough.

Overall, we are pleased with the shift we have made in the past couple of years away from a narrow sector of the community receiving grants – to an increased number and variety of organisations benefiting from our funds.

# COVID-19

The challenges of 2020 were front of mind for the Trust during the recent round of community grants. There is a clear and increased demand on some community organisations directly related to the impacts of COVID-19 on our community. However, there are many other community organisations undertaking equally important work which must continue.

## Administration

We continue to have Natalie Vincent as our Trust Manager. Her work with applicants, her organisational skills and commitment to our community are invaluable and her efforts are greatly appreciated.

#### Financial

The Trust's accounts show a small deficit in operating costs this year, mainly occasioned by some unexpected costs and lower than budgeted interest income. However, our reserves remain healthy. Our priority is dealing with noise mitigation package grants, however these have stabilised largely due to the already dense housing in the area of benefit and a reduction in the number of hardship grants received. We continue to have adequate reserves which currently are at a level of \$390,151.

# Governance and Appreciation

One of our Trustees departed July 2020 and we sincerely thank Emma Howie for her contributions during her term of office. As a result of this, we were pleased to welcome Maria Tuamoheloa as an Airport Company's appointee. I take this opportunity to sincerely thank our Trustees and Natalie for their untiring efforts in the work of the Trust - and to all recipients of grants, thank you for providing services and projects to those within our area. Working together we can and will make a difference!

# **Auckland Airport**

The outbreak of COVID-19 has brought a great deal of change to Auckland Airport – but one thing that remains steady is our determination to be a good neighbour in the South Auckland community. That's why we're so proud to play a part in the work of the Auckland Airport Community Trust.

In the 2020 Financial Year, we granted the Trust \$345,781. These funds are dedicated to support community groups in areas where people are directly affected by aircraft noise.



During this time, 18 groups received community grants supporting a wide variety of activities, including sporting-facility development, artistic activities, youth support, environmental improvement and conservation initiatives, volunteering programmes, and programmes designed to help elderly and disabled people within our communities.

Some of the very worthy recipients of these grants include Garden to Table, an organisation which teaches essential food skills to children, and Sistema Aotearoa, an Ōtara-based organisation working to bring about social change through orchestral music-making. The Trust also supports low-income homeowners to get noise-mitigation packages installed in their homes.

I'd like to acknowledge the work of Emma Howie, the airport's representative on the Board since February 2019. As Emma has left the airport, she's been replaced on the trust by Maria Tuamoheloa. We are grateful to all the trustees, manager Natalie Vincent and the many others who so ably support the Trust in its work within the South Auckland community.

# Garden to Table

Garden to Table is changing the way children think about food

"What a day! I had so much fun today! I can't wait until my next Garden to table class".

The Garden to Table Trust is a charity driven by a vision of Aotearoa where our tamariki and communities are healthy, empowered and resilient through their ability to access good food. The Garden to Table programme, run in schools, is a curriculum-integrated programme that provides real-world learning opportunities, taking learning outside the classroom.

We know that many children have no idea where their food comes from and what is in it, let alone how to prepare it. We want to empower children with a love of good, fresh food and the skills they need to grow and prepare it. So all around the country, thousands of children are enthusiastically getting their hands dirty and learning how to grow, harvest, prepare and share fresh, seasonal food, all while having fun! As one student said, "What a day! I had so much fun today! I can't wait until my next Garden to table class".

By making food a positive part of children's lives, we hope they will make better food choices and influence their whanau and community to do the same.



# Adventure Specialties Trust

Adventure Specialties Trust were excited to partner with Auckland Airport Community Trust, to provide a leadership adventure camp for 12 Aorere College Prefects. This was a once in a lifetime experience for these young people, which would not have been possible without the generous funding from AACT. The focus of this opportunity was to input into the future leaders of the school, so that they in turn can benefit the whole school through their mahi and positive

The programme included the students traveling to Paeroa where they began their haerenga of mountain biking, abseiling, swimming and tramping their way back to Franklin Road.

The students slept in tents or remote cabins, camping out and cooking all their own food on camp cookers. The focus of the week was on leadership development and teamwork. By taking part in challenging adventure activities the students developed their leadership "toolkit" and used teamwork, challenges and resilience to grow closer together as a leadership team. Our instructors facilitated discussions to help the students' identify strengths and weakness they see in the school culture (including school spirit, events and dynamics) and what actions they wanted to implement over the next 12 months to create positive changes and developments in the

It was exciting to see the growth in these young leaders through the experiences they shared. Some of their own comments from the evaluation forms included:

# Sistema AotearoaTrust

Sistema Aotearoa's vision is to unleash the potential of tamariki, whānau and communities through orchestral music. We are a social change & youth development programme that uses orchestral music making to foster confidence, leadership, educational excellence and aspiration in the children taking part, and through them promote these same values throughout the wider South Auckland community.

Sistema Aotearoa works with tamariki and rangatahi throughout Ōtara, including students at eight partner primary schools. In 2019 we impacted more than 1,100 ākonga through all elements of our programme, working with students from 32 different schools and 9 ECE Centres in South Auckland.

Thanks to the support of the Auckland Airport Community Trust, we have been able to expand our successful Pūoru Pōtiki programme to reach Year 2 children at Rongomai and Dawson Primary schools within the Area of Benefit. Students at both schools face significant barriers to accessing the arts and music education, and we have worked collaboratively with the schools to find solutions to maximise whānau involvement and benefit from the Sistema Aotearoa programme.

In 2020 we created a year-long programme of activity for Year 2 tamariki in Rongomai and Dawson schools. Pūoru Pōtiki provides the foundation for life-long music making to children through learning an orchestral instrument within school time, allowing inclusive and universal free access to the programme. Fundamental basics of musicianship are introduced in a carefully sequenced, fun and age appropriate way including pulse, pitch, rhythm, tonic solfa, aural awareness and music notation.

Tutors have noted that ākonga are very engaged in the programme and are keen to show what they have remembered from previous sessions. Tamariki particularly enjoy hearing tutors perform on their orchestral instruments, including violin and cello, and are particular interested in links to emotions and feelings, supporting wellbeing. Teachers and tutors have reported increases in confidence and independent learning, including tamariki

working in a self-directed way to practise their rhythm reading, or working creatively to compose their own music.

With the support from the Auckland Airport Community Trust in 2020, these tamariki have all received a critical kick start in their lives, with self-confidence, focus and aspiration all enhanced by their participation in the programme. We are very grateful to the Auckland Airport Community Trust for their support, helping to create the long-term impacts for tamariki, whānau and the wider Auckland Airport neighbourhood the Sistema Aotearoa programme has been proven to be making.

"Sistema Aotearoa is about more than teaching music. Of greater significance is the education, social and behavioural impact the programme has on the children at Rongomai School. We believe we will see transference of knowledge and skills, where our Sistema pupils have not only increased their musical capabilities, but their academic levels and confidence too."

# Entity's Purpose or Mission:

"The Auckland Airport Community Trust's purpose is to hold and apply the Trust Fund upon trust for the following charitable purposes for the benefit of those living and working in the Area of Benefit and affected by noise from Aircraft Operations:

- (a) for the mitigation of the adverse effects associated with noise from Aircraft Operations which are not provided for under the Operative Manukau District Plan 2002;
- (b) to ensure positive effects on the external environment to offset the other adverse effects, including but not limited to the provision of opportunities and facilities to provide enhanced cultural, recreational and other opportunities to those living and working in the Area of Benefit.
- (c) in cases of significant financial hardship, to assist property owners in the Area of Benefit to meet their share of any costs of acoustic treatment measures or enhancements where such a contribution by an owner is required by the above mentioned District Plan.

## **Entity Structure:**

The Auckland Airport Community Trust appoints Trustees to govern the Trust. The number of Trustees at any time shall always be five. Each Appointer of the Trust has the power to appoint and remove the number of Trustees specified below;

- Auckland Airport Limited (Settlor) Two Trustees
- Auckland City Council Two Trustees
- Aircraft Noise Community Consultative Group One Trustee

## Main Sources of the Entity's Cash and Resources:

Auckland International Airport Limited (Settlor) is required to contribute the sum of \$250,000\*, or the adjusted sum to compensate for inflation, per annum to the Fund. The Trust also receives interest on invested funds.

\*adjusted and increased annually by the percentage increase in the consumer price index (all groups).

#### Entity's Reliance on Volunteers and Donated Goods or Services:

All current Trustees are volunteers and do not receive any reimbursement or remuneration in return for their services.

# Additional Information:

## **Community Grants**

The requests to the Trust for the funding round that closed on 16th August 2019 exceeded \$1.4 million. This required the Trust to be very selective in its decision making. The distribution was made to a broad range of organisations across the Trust's funding priorities.

# Micro-funding Grants

In May 2019 the Trust introduced a new funding opportunity called micro-funding. These grants are a quick response grant-making programme whereby applicants can apply for a grant ranging from \$500-\$2,500 to assist with immediate and small scale needs. In the year to 30 June 2020 the Trust made 11 micro-grants (5 micro-grants to 30 June 2019).

## Financial Assistance Grants

Auckland Airport covers 100% of the cost of installing noise mitigation packages in homes in the High Aircraft Noise Area (HANA) around the airport. The package includes a ventilation system to circulate fresh air through the home, a heat pump to provide heating and cooling and a kitchen extraction fan to allow windows to be closed. Auckland Airport covers 75% of the cost of installing this package in the Moderate Aircraft Noise Area (MANA). People in the MANA suffering financial hardship can apply to the Trust for funding to cover the remaining 25%.

# **Basis of Preparation**

Auckland Airport Community Trust has elected to apply PBE SRA-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis it does not have public accountability and has total annual expenses of equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

# Goods and Services Tax (GST)

All amounts are recorded inclusive of GST.

#### Income Tax

Auckland Airport Community Trust is wholly exempt from New Zealand income having fully complied with all statutory conditions for these exemptions.

# Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

# Debtors and prepayments

Debtors are recorded when action is taken (such as goods or services sold) to give the entity the right to collect cash in the future. Prepayments are recorded when payment is made.

# Property, plant and equipment

Property, plant and equipment is recognised at cost where the property, plant and equipment is purchased, and at current value where the property, plant and equipment is donated.

#### Depreciation

Depreciation is provided on a straightline basis on all fixed assets at rates that will write off the cost of the assets over their useful lives. The useful lives and associated depreciation rates of major classes of assets have been estimated as follows: Computer hardware 33.33%

#### Investments

Investments are recognised at the amount paid when purchased.

# Creditors and accrued expenses

Creditors and accrued expenses are recorded at the amount owing when transaction occurs that creates the payment obligation, for example on the receipt of goods or services from a supplier.

#### Trustee Funds

Trustee funds comprise of accumulated surplus over the years, Endowment Fund Reserves and Hardship Grant Reserves. Endowment Funds Reserve are funds left to build up and be used for major community projects at some future date. Hardship Grants Reserves are funds set aside for future approved hardship grant distributions.

## Revenue from donations, fundraising and other similar revenue

Donations/grants with no "use or return" conditions are recognised as received. Donations/grants with use or return conditions are recognised as a liability and recorded as revenue when the conditions are satisfied.

# Revenue from interest, dividends and other investment revenue

Revenue from interest is recognised as earned during the period.

# Costs related to providing goods or services

Costs are recognised on an accrual basis as services are provided to the Trust.


## Maria Tuamoheloa
