1. Apologies / Introductions:

- Ms Nicholl opened the meeting introducing the new independent chairperson of ANCCG, Mr Shand, and handed the meeting over to Mr Shand to chair.
- Round table introduction.

2. Minutes of previous meeting:

- The Group confirmed that the minutes of the 16 December 2015 were a correct record of the meeting.

### 3. Matters Arising:

- Mr Ting updated the group that the discussion with Airways NZ on the time delay on Auckland Airport's Flight Monitor is ongoing and he will update the group once there is progress.
- The group then enquired on the availability of the number of visits ("hits") to the Flight Monitor website. Auckland Airport undertook to investigate this matter and will advise the group at the next meeting.
- The analysis of the noise data collected from the seven temporary noise monitors placed in the community is ongoing. Auckland Airport will distribute the report when they are available.

### 4. Community Feedback:

- Mr Lauese commented that the noise generated by the low flying small propeller aircraft operated by Great Barrier Airlines and Fly My Sky are affecting the Mangere area and that he has received a number of complaints. It was noted that no complaints about propeller aircraft operators have been recorded in the formal complaints system, in the month of January and February 2016.
  - o Mr Ting advised Mr Lauese to advise his local constituents to either log on to Auckland Airport's Flight Monitor ([www.aucklandairport.co.nz/flightmonitor](http://www.aucklandairport.co.nz/flightmonitor)) or call the airport's noise hotline (09 - 256 8133) anytime to log aircraft noise enquiries for further investigations.

### 5. SMART Approaches Update:

- The group was advised that all SMART approaches flight paths both from the north and south have stopped since the beginning of February and will resume on 1 April. This is due to the reduced operating length of the runway to enable maintenance work to be undertaken on a neighbouring taxiway.

### 6. Noise Complaint Summary / Trends:

- A copy of the noise complaint report was distributed and was discussed. The downward trend in complaints was noted.
- The group discussed the possibility of having a more concise report made available online for the public to view and agreed this should be pursued with Auckland Airport.
- There was a discussion on the medium-term need for more clarity on the nature of complaints – flights, etc.
- The group also suggested some amendments to the categorisation of the top 10 complainants. It was recommended that this become a revolving list of the top 10 complainants based on those enquiring 20 times or more over a period of six months. Auckland Airport undertook to review this matter.
- Mr Filipaina recommended the legend / key on the "Location of Enquirers" map be made easier to read.

7. Noise Management Website:

- The group was updated on the phase 2 of the noise website enhancement project, being the commissioning of various short videos to complement the enhanced content of the website. The videos will be included in the upgraded Auckland Airport website later on in the year. The videos were showed and some suggestions were made for future reference.

8. Auckland Airport Community Trust:

- Mr Lauese updated the group on the community trust's activities.
- Mr Filipaina suggested some form of reporting packs for the ANCCG.
- The group suggested inviting Mr Fryer, one of the trustees, and Mr Lauese to update the group on the Trust's activities at the June meeting.

9. General Business:

- Before closing the meeting, Mr Shand suggested future agenda items for the 2016 year, namely,
  - o Amendments to the Group's Terms of Reference as per Auckland Airport's PAUP submission.
  - o The Yellow U23 SMART approach flight path trial and public consultation.
  - o Noise Management Plan, when it is available from Auckland Airport.
  - o Reviewing the 2015 Annual Noise Report when it is available from Auckland Airport.
- There being no further business, the meeting closed at 3:30 p.m.
