### 5. Rules and Procedures Review

Michael Clay tabled a proposed new complaint procedure in which members of the public would be capped on the number of flight event investigations that can be made within a defined period. Garry suggested that if a series of complaints were made about the same flight event then Auckland Airport should investigate even if a member of the public has used up their quota. Eric had some uneasiness to having a hard number as they may miss genuine complaints. Eric believes that ANOMS upgrade will help as people can investigate flight events by themselves. John mentioned also that aside from this proposed change in procedures Auckland Airport was going to start to provide more educational material to the public as well. Kristina expressed that she thinks 15 flight events in 3 months is a little low and if one complaint is valid then it should not count towards one of the 15.

### 6. Reports on Noise Complaints and the Noise Monitoring System

Michael Clay tabled a proposed new report for ANCCG members. ANCCG members liked the new format and Noel would like to see this presented at the next meeting, with one A3 page for each month and then a summary of the quarter on an A3 page.

David C/Alf asked the question why altitudes of aircraft cannot be monitored automatically and then a report sent out highlighting those who have breached the NAP rules. This would mean we would be on the front foot when dealing with complaints. Eric advised that this technology was not available yet, however Michael Clay advised that he was shortly commencing a world
