4. Community Board Feedback

Maungakiekie-Tāmaki- Simon advised that he is still receiving a lot of noise complaints and he had a number of requests with regards to the SMART trial. Members of the public want to know how to make submissions and they have raised concerns about the future of SMART approach consultations and the distrust of decision process for implementation. Eric raised the point of what are the local boards doing to help the distrust issue and Simon advised that he was encouraging members of the public to make submissions through the public process.

Mangere- Tasi advised he is still receiving a large number of complaints mainly with regards to small aircraft. Sees a raised awareness of aircraft noise from the recent SMART trial publicity.

5. Rules and Procedures Review

No changes to rules or procedures have been made.

6. Reports on Noise Complaints and the Noise Monitoring System

Matthew provided an update on the noise complaints status.

Matthew provided a demonstration of ANOMS 8 product to members. Simon asked whether additional noise monitors are part of the project. He is worried that if noise parameters are exceeded and the public can view this on the website. Mike acknowledge these concerns and said that education would be needed on how to interpret the website data but overall would make noise aircraft management more transparent. Funding for this project will be shared with the Auckland Council. John from BARNZ stated that they support the upgrade. Noel, Tasi and Alf all stated their support the upgrade. Simon stated he supports the upgrade, especially of it provided the public more information

7. Auckland Airport Community Trust (AACT)

Matthew advise members that Julie Wade has resigned as the ANCCG representative on the AACT. Matthew to make arrangements for a new representative to be voted in at the next meeting.
