Aeropath has identified that it may be possible to lift the minimum aircraft height at LOSGA by 1000 feet (from 6000 feet to 7000 feet) for night flights. This is to be tested to ensure there are no unintended consequences when there is a tail wind (such as aircraft needing to deploy flaps to reduce speed at Beachlands when turning at the VIBAG waypoint).

6	Investigate level of flight correlation at the Velodrome noise monitor, which is one of the three mandated noise monitors used to determine the annual AANC, and hence the noise mitigation offers.	13/9/21 13/12/21 14/3/22	P Thacker K Cooper	13/6/22	Correlation configurations on all noise monitors are currently set so that the system will only record noise events which are 10 dB higher than the surrounding ambient noise. This prevents or reduces the number of false readings. Casper has investigated the reduction in correlation rates and advised that the Velodrome correlation rates are being impacted by two factors: • There are a number of local community performances or events near or under the microphone which affects correlation as the aircraft noise is not 10 dB higher than the other noise in the vicinity • The increase in the proportion of turbo-prop movements as a proportion of total flight (due to the significant reduction in jet aircraft as a result of COVID 19) has meant that the proportion of correlated flights has dropped. Turbo-prop aircraft are quieter and therefore will not always trigger the 10 dB noise differential. CASPER technicians are investigating whether the configurations can be adjusted, while still achieving an appropriate balance of not having too many false positive recordings. The ANCCG will be further updated if configuration changes are made. Note calibration and availability of the Velodrome monitor is consistently returning at 100% (or very close to).
